Background

Florida's Association of Healthy Start Coalitions (FAHSC) harnesses the power of over 30 years as a leading nonprofit in the state of Florida to improve the lives of families through programs and services developed to meet their needs. Using a community-focused model, FAHSC supports 32 Healthy Start Coalitions throughout the state with programs tailored to their unique communities.

Services are provided through a suite of programs based on proven methods for delivering a continuum of high-quality care that's accessible and affordable. Our programs include education and support for pregnant and post-partum women, resources for parenting infants and children up to the age of three, education and support for dads, methods for connecting families to resources and services in their communities, access to doulas, and more. Additionally, an important part of our work includes federal funding for evidence-based home visiting services. Some of FAHSC's operations are managed under the administrative service organization, Healthy Start Momcare Network (HSMN).

Purpose

This request for proposal (RFP) seeks a firm to provide professional website design and development for FAHSC. As a leading advocate for maternal and child health and as part of our continuing dedication to Florida families, FAHSC seeks to improve our digital presence through an updated and expanded website that better represents our organization, mission, and purpose.

Current Websites

We currently own four domains and maintain three sites that were each created at different times. The main FAHSC site is healthystartflorida.com but we also own the domain healthystartmomcarenetwork.org, which redirects to the main site. Having separate domains for FAHSC and Healthy Start MomCare Network (HSMN) is necessary for administrative purposes. The Connect and home visiting sites are redundant and will be reduced to a single site under the home visiting domain.

Issues with current websites to be corrected with rebuild:

- Inconsistent design
- Ineffective content organization
- Confusion about FAHSC/HSMN relationship
- Lack of content to attract target audience
- No search engine optimized (SEO) content
- Content copy isn't engaging

Objectives

- 1. To create a website that represents FAHSC and our programs in a manner that's aligned with our mission and values, our partnerships, and grant requirements as applicable.
- 2. For the FAHSC website to establish a unique digital presence that appeals to our varied audiences and meets their needs for information, resources, and support while also promoting FAHSC, our coalitions, and our programs. See the website map included on page seven for more details about content.
- **3.** For the FAHSC website to be a one-stop resource and respected authority for maternal and child health information and guidance.
- **4.** To bring the multiple sites that are currently used for FAHSC and our programs under one comprehensive site with a central landing page and unified design.
- **5.** Created with a platform that allows for FAHSC to make our own changes and updates as needed. WordPress is preferred.

Scope of Work

Using proven methods, the selected firm will design, develop, and implement the FAHSC website from start to finish. Website hosting is not included in the budget cited on this RFP; however, FAHSC is interested in using the chosen vendor for hosting if this service is available and the cost is within our budget. If hosting services are not available with the chosen vendor, FAHSC will seek hosting elsewhere. If the respondent chooses to include hosting in their proposal, pricing for (1) design and development and (2) ongoing website hosting must be shown separately.

Domains

We'll keep healthystartflorida.com, healthystartmomcarenetwork.org, and flhomevisting.com with the Healthy Start domain as the main site. We'd also like a quote to purchase healthystartflorida.org, should it be available. If healthystartflorida.org is available, we'd like this to be the main url.



Elements of redesign

The rebuilt site will use the new FAHSC branding, which is projected to be available in April 2024. Additionally, the site will convey that FAHSC is a community-based nonprofit that serves all Florida families. We're experts in maternal and child health and we're here to help with programs and resources that are inclusive, proven, and designed to meet the needs of moms, dads, and babies. The new site will utilize search engine optimized content to attract our target audience.

Number of pages

The site is estimated to have 40–50 pages.

Copywriting, images, illustrations

The selected vendor will supply all images, including graphics, photographs, and illustrations unless FAHSC already owns the images. For example, FAHSC will provide all logos and branding assets. The selected vendor will provide all website copy except for program or organization specific content that requires FAHSC's direct input. For example, program descriptions, staff bios, organization history, and some boiler plate content will be provided by FAHSC. Content for the article bank, interactive tools, page headers, and general descriptive content throughout the site will be provided by the vendor. See page eight for more details about content.

Content migration

As this is a rebuild, we don't expect to migrate content.

Multilingual support

The site will be designed with a translation tool so that it's available to the user at a minimum in English, Spanish, or Creole.

GDPR compliance/regulations/security

The site will be compliant with all current regulations and be secure from cyber threats. The cybersecurity performance of the site will be monitored regularly using open-source intelligence. Vendor is expected to remediate any issues discovered.

ADA compliance

The site will be ADA compliant.

User testing

Three rounds of user testing will be implemented before the site is live.



Qualifications

Proven experience with:

- Design and development of professional websites
- Creating websites with complex content and user needs
- Cybersecurity performance
- Website hosting (if including hosting in proposal)
- Working with government entities and nonprofits
- Statewide campaigns or projects in Florida

There is a strong preference for firms who are familiar with Florida Healthy Start and have proven success in reaching the target audiences.

All submissions will be reviewed and scored by an independent panel of reviewers. Review criteria and points are summarized below.


